**ANNUAL DUES STRUCTURE**  
**(Membership year runs from June 1<sup>st</sup> through May 31<sup>st</sup>)**

MBBA-NH is the state affiliate of the National Association of Mortgage Brokers (NAMB), and we are pleased to sign you up as a NAMB member as well as a MBBA-NH members. The following is important information you should know about joining NAMB:

1. MBBA-NH requires its mortgage brokers member, holding only a mortgage broker license with the New Hampshire Banking Department, to join NAMB
2. MBBA-NH offers all other members the option of joining NAMB: mortgage bankers that have a mortgage banker license with the New Hampshire Banking Department, credit unions, community banks, national banks, wholesale lenders, and affiliates
3. MBBA-NH membership is required for NAMB membership
4. MBBA-NH members are companies, whereas NAMB members are individuals
5. Loan originators may join NAMB individually only when the company for which they work have a NAMB Professional Membership.

**Regular Members** – Mortgage Bankers, Credit Unions, Community Banks, National Banks, and Wholesale Lenders:

MBBA-NH Membership Only	\$595/year
NAMB Professional Membership (optional)	\$120/year are the dues for a regular member who is the Primary Contact.
NAMB Associate Membership (optional)	\$45/year are the dues for loan originators and other individuals employed by a regular member.

**Mortgage Broker** - Mortgage Brokers Maintain a Broker License only. All Mortgage Broker Employees are Required to Join both MBBA-NH and NAMB:

MBBA-NH and NAMB Membership (required)	\$245/year are the dues for the mortgage broker who is the proprietor and only employee of his/her company or employs five (5) or less employees.
MBBA-NH and NAMB Membership (required)	\$75/year are the dues for each of the first five (5) loan originators and/or other employees who are employed by a mortgage broker.
MBBA-NH and NAMB Membership (required)	\$420/year are the dues the mortgage broker who employs six (6) or more employees. The cost covers: MBBA-NH membership for the proprietor and all his/her employees and NAMB membership for the proprietor only. The cost does not cover NAMB membership for the proprietor's employees. The cost for the proprietor's employees to join NAMB is an additional \$45 each. See below.
NAMB Membership (required)	\$45/year are the dues for loan originators and other individuals employed by a mortgage broker who has six (6) or more employees.

**Mortgage broker Example:** If you are a mortgage broker and employ three (3) people, your total dues are \$295/Proprietor + \$225 for employees = \$520 for MBBA-NH and NAMB dues. The breakdown is as follows:
